

# President's Desk

Bessed with abundance of natural resources, the North East Region offers immense scope for trade and business to flourish in various sectors. However, even as the country has seen many start-ups transform their innovative ideas into sustainable businesses over the past decade, the Region has not seen a commensurate evolution of such ventures.

But the good part is that the few who had ventured out to transform their ideas into reality have been successful in sustaining their ventures. There is a strong need for an eco-system to boost the development of startups in this region, especially in sectors such as agriculture, tourism and hospitality, food processing, business process outsourcing, electronics and electricals, healthcare, agro-based industries, inland water transport and solar energy. Compared to the rest of India, entrepreneurial activity in the start-up segment has been rather less primarily because of factors such as infrastructure, access to funds and skilled manpower. Then again, lack of big industries is an obstacle as many start-ups, particularly those in IT, cater to large organisations.

It is also pertinent that the government, the academia and financial institutions join hands to facilitate a support system for new entrepreneurs.

The Department of Industries and Commerce, Government of Assam and Assam Gramin Vikash Bank recently signed a memorandum of understanding (MoU) for the Chief Minister's Startup Fund, Sarothi. The scheme offers financial assistance in the form of loans from the bank with subsidy on interest rates to all innovative start-up industrial activities.

Creation of venture funds to support existing and aspiring entrepreneurs is significant. The North Eastern Development Finance Corporation Limited (NEDFi), in collaboration with the Ministry of Development of North Eastern Region has set up the North East Venture Fund, a dedicated venture capital fund for the region, to encourage Start-up ventures in the region. The focus of the fund will be on early and growth-stage investments, mostly in the fields of IT & ITES, food processing, healthcare, tourism, retail and aggregation of services.

The Union Cabinet is expected to approve setting up of a Rs 2000 crore credit guarantee fund by July-end with a view to provide collateral-free funding facilities to start-ups, which augurs well for the start-up scenario in the North East. Besides, the Start-up India Hub portal which was launched recently will be an ideal platform for budding entrepreneurs and keep them informed about government schemes, mentors, venture capital firms and facilitators.

So while there is a lot of catching up to do, the flip side is that with a system in place and funds for the taking, there is immense scope for start-ups in North East to plug in and get started.



# MY ENTREPRENEURIAL JOURNEY

As they say, the journey of an entrepreneur is a journey of self-discovery and it all starts with discovering that one dream which won't let you sleep. Like any other entrepreneur, I was also a dreamer. For some, it was a sixfigure income and for others, it was more about inspiring people. But for me, it was all about improving the present economic condition of Manipur by utilizing the already available resources, generating employment for the underprivileged and manufacturing world class products, all in one stroke. Until recently I was scared of dreaming because too many dreams have been shattered. There was a time when I wanted to be a caterpillar safely ensconced in my shell of mediocrity and I didn't want to fly. I had tried flying and had my wings clipped by my own failings. But no matter how hard you try to be nobody, you just need to be somebody. The dreams aren't going to go away as they are not to be fulfilled but to be lived. It's walking the way which is the real trip.

ntrepreneurship is all about your ability to take risks, but to start a venture in a less favoured place like Manipur where the business eco system is non-existent is beyond imagination. Starting a venture in the North East always has the disconcerting knack of unsettling our minds over the matters we took for granted. There would be times when you would have the impression that you are holding a bubble which might just burst anytime. So, it's more about how fast you can adapt to the volatile nature of this region. What might work in other parts of the world might not work in this part of the country because we have a very different business eco-system. This is when I say, act like a north-easterner when you are in the North East. It's all about your ability to adjust well with the environment because management I believe is all about managing men and how you excel in it. If I have to speak from my experience, it's better to start a venture by utilizing the already available resources and come up with something unique by finding the gap in the market. As an entrepreneur and as a start-up, I believe it is important to identify the gap in the market and bridge it because you cannot succeed as a start-up unless you are solving a problem. This is exactly why I founded the SuiGeneris and launched my first herbal green tisane - brand named CC Tea. As we know tea is the most widely consumed beverage next to water and is sold at a quantum of 4.6 million tons a year, the idea of coming up with an alternative beverage sans



caffeine was really exciting. As more and more people are becoming health conscious, an alternate beverage to bulldoze the addictive caffeine habit was in the offing and I took up the challenge left, right and centre. I always knew CC Tea could be the next big thing if marketed the right way. CC Tea is a 100% Organic and 100% Natural herbal/ green tisane and is certified organic by SGS India and has received approval and license from FSSAI. This is a natural green tisane which is revolutionizing an entire generation of tea drinkers and is finding insightful penetration in the lives in and outside of Manipur. It has no additives, is naturally caffeine free, is rich in antioxidants, and most importantly, has a very distinct yet appeasing lemony taste. Nevertheless, the journey of CC Tea was no less thorny coupled with failures and rejections. But from a meagre 3



employees, SuiGeneris now stands tall at 1000+ workers driving the company for growth.

So, my dear entrepreneur friends, sustainability will remain the top trend in the next coming years and food businesses that embrace sustainability will be the rockstar. When we talk about food business, where else can we go rather than our exotic North East with gently undulating hills, emerald green valleys and blue lakes with miles and miles of virgin fertile lands. Home to many rare species of flora and fauna, North East's unique topography produces many rich yields.

As I mentioned earlier that I am a strong believer of the Startup system, I believe if you take a group of people with the right equity incentive and organize a

> startup, you can unlock human potential never before possible. They can achieve unbelievable things. So, I met a few young entrepreneurs in the region and asked them what are the most important factors they think is important to start a business and they said, No.1. Business Idea. No.2. Funding. No.3. Team. No.4. Business model. No.5. Timina. But an extensive study was done of the factors which matters the most in a startup with 100 highly successful Startups and 100 failed Startups and the result is pretty different: No.1. Timing. No.2. Team. No.3. Business Idea. No.4. Business Model. No.5. Funding.

> When I talk about 'Timing', I am sure we all have heard about Airbnb. As we know they are an online marketplace to rent out homes for vacation and other purposes. No one believed this idea and every investor rejected this idea thinking that no one would rent out their homes to strangers. But the economy was in the height of its recession and everyone wanted some extra cash. At the same time, customers wanted to save some extra cash because of the tough economy and preferred for a homestay. And there you go, Airbnb is one of the most successful startups in the history. Let's also talk about Z.com, an online entertainment company. They had the perfect business plan and heavily funded and they even signed some incredible Hollywood talents. But the broadband penetration was

really low in 1999 and 2000 and it was tough watching video online because you needed codecs and other stuff to watch it and eventually it went out of business in 2003. Right after two years Adobe solved the codec problem and with better broadband penetration YouTube was launched and perfectly timed. When YouTube



started, it didn't even have a business plan but it was perfectly timed. So, it's more about knowing when to push the button.

Don't worry and don't wait for the best plan. Please remember, you will never have a perfect plan at the start. The number one ingredient in coming up with a business idea is to find a problem. You need to identify a pain point. Then you need to come up with a solution and see if friends and families would buy it. If no one is willing to pay for that idea, then you better come up with something different, something better. This is why they say, everybody has a plan until they get punched in the face. So, there is a thin line between being persistent and being stupid. It's for you to decide which one you want to become. If you feel that there is merit in your business idea, then you can persevere, if not you have to pivot. Pivot in simple language is like having a plan B. The perfect example would be about an app called Burbn with contents of Mafia wars and other features. The result was not as expected and the founders see that it was failing. But the photo clicking feature option was pretty popular among the users so they pivot their idea towards making the photo clicking feature better and thus Instagram was born. This is why I always say, never fall in love with your idea. It's not always about re-inventing the wheel, it's more about building a better mousetrap. But remember, don't come up with something which no one needs.

Once you have your idea in place, build a good team who can execute the idea well and bootstrap in the start. Don't spend money on unnecessary things. And my dear friends, never be afraid of failures. The greatest achievers are the ones who fail the most because they are the ones who try the most. When someone asked Mr. Edison whether he felt bad because he failed a 1000 times before coming up with the light bulb, he replied – not at all. I didn't fail 1000 times, it's just that the invention took 1000 steps. So, don't give up. You have to see the invisible to achieve the impossible.

After we design a proper business model, it is time we go for the proof of concept. Once we start getting some traction, it is then time to reach out for funding to further grow the business to the next level. The journey from the concept stage till bringing an investor on board is a long crusade but is reasonably easier if you do all the things right. With various funding options available now like Angel Funding, VC Funding and Crowd funding, it is for the entrepreneur to decide what suits the business best. As it is not very wise to start a business with debt as it will siphon off cash when the business needs it the most, the entrepreneur can still opt for a bank loan as the last option.

Lastly, it is not about the What and also not about the How, it is more about the 'Why' of the business that is important. The world wants to listen to the stories as to why you have started this venture. So, the most important question to be answered when starting a business is the 'WHY'.

In a region that has one of the highest number of unemployed youths and the craze is always about government jobs, I could have easily opted for a white-collar job but as Robert Frost said, "Two roads diverged in a wood and I - I took the one less travelled by, and that has made all the difference."

The reason I wanted to be a caterpillar is because I was scared I might not make a kick-ass butterfly. But now I figure it doesn't really matter if I turn out a moth. The satisfaction is in the fact that I had dared to live my dreams.

# PARADOX OF START UP What It Needs To Start Up In NER

# Background:

Entrepreneurship was a dream to be had and forgotten. Most middle class Indians would not have ever thought about giving up a crore plus salary to try out a business idea until as late as 1990s. Today they feel free to make such choices – free from the stigma of potential failure, free from the parental pressures to settle down in life, free to try making their own economic destiny.

Three changes have ushered in this freedom. First is the gradual rising value of acceptance of enterprise as a

there is a long list of 'succeeded in the second attempt' entrepreneurs in the country. Another big change is in the thinking of what's business and who's an owner. Startups change their business model and products significantly during the period of experiment. Founders of some of the biggest start ups have no hesitation in reducing their stake to less than 50% to ensure that their ideas and business bloom even if they no longer have control.

Entrepreneurship is well known to be one of the key drivers for development of any nation. It is indicative of a

country's prosperity; it's capability to be a job provider rather than be a job seeker. On the global map, United States of America is a world leader in entrepreneurship with the sturdiest global economy. Entrepreneurship is deep rooted in the history of the US. This thrust towards entrepreneurship development in the US is evident in its close relation between the industry and the universities. Stanford University is a pioneer in promotion of entrepreneurship development with half of the startups in Silicon Valley having roots in Stanford. The US also boasts of a very strong venture capital industry with its first venture fund, the American Research and Development Corporation, founded in 1946. Today, the industry has an unrivalled mixture of resources, expertise and customers. Hence, an unparalleled eco system for entrepreneurship in the US makes it an entrepreneurial hub.

career choice. Second big change is how career is seen in society and among investors. Though India is far more risk aversive than America, more and more young Indians are seeing failure as a learning and not as an ending. By now,

India has a pioneering status among the developing nations for its early start on a variety of entrepreneurship education programmes since the

1950s, and for the most part entrepreneurship education in post-Independent India had its aim to encourage selfemployment and founding of SMEs. As the economy transitioned from being a primarily agrarian into one that had significant contribution from other sectors, it was felt that the most pressing requirement was education that would enable

need-based entrepreneurs to foray into these emerging sectors. And in 1999 the Government took steps and the Ministry for Micro, Small & Medium Enterprise (MSME) was set up to provide thrust towards enterprise development. Gradually the MSME sector began to grow and there was a growing inclination towards entrepreneurship. As the eco system developed, the educational institutes also took up the responsibility to provide an entrepreneurial boost through their curriculum and started with entrepreneurship development programmes. The premier institutes gradually leaned towards setting up of incubation facilities, mentoring programmes for igniting and nurturing ideas and this brought in the emergence of startups.

Majority of the big names in start-ups have emerged from the premier educational institutes like the IITs and IIMs. But it is high time that the other educational institutes like engineering colleges across the states, management institutes, etc also take up the responsibility to promote entrepreneurship and augment the generation of ideas in the campuses. This will enable the startup bug to reach across different colleges and universities in the country and help young talents build their businesses even from the smaller cities and towns.

Young well educated and well informed individuals with innovative thinking, risk taking characteristics, leadership qualities, determination, focus etc. are emerging as the new age start-up entrepreneurs. Start-ups have come up across the country in various sectors such as food, agriculture, health, financial services, e-commerce, taxi aggregators, etc. There is no dearth of investors for scalable ideas, and for this, an enabling eco system is a must.

# India and Start Ups:

In the last five to six years the start-up scenario in India has seen a lot of activity and has blossomed into a key contributor to the country's entrepreneurial economy. Major contributor to this trend has been the mega funding that has been pumped into the best start up ideas. On the

global map India is the 3<sup>rd</sup> largest start up hub with US and China holding the 1<sup>st</sup> and 2<sup>nd</sup> spots respectively. This year has seen a major boost to start-ups with the Government of India launching the Start Up India initiative in January 2016. With this initiative, a roadmap for the Indian startups has been envisaged. India saw a mammoth funding of \$7.3 billion in startups in 2015. When we speak of funds, it is seen that the major share of funding has come through venture capital with 466 deals in 2015 with a value of worth \$5394.58 million. Global VC firms like Sequoia Capital, Accel Partners and Tiger Global etc. have all invested in



Indian startups in recent years. Be it Flipkart, Chaayos, Ola, OYO Rooms, Zomato, Paytm, Grofers etc. – all have received VC funding. The top funded startups may be classified broadly into enterprise tech, fintech and retail.

This surge in funding affirms the presence or the growth of a good eco system that is promoting entrepreneurial initiatives in the Indian society.

However, it is notable that majority of the startups and investors are from the metro cities (Bangalore being the startup capital of the country) that offers more opportunities to the entrepreneurs in terms of attracting investments from VCs, better incubation facilities, technological advancement, access to varied markets, mentorship programs, in-campus



idea generation opportunities etc. Last year, the highest number of startps founded were from NCR (1060) followed by Bangalore (925), Mumbai (546), Hyderabad (243) and Pune (171). Even the premier educational institutes like IITs, premier engineering colleges, top management institutes etc also boost entrepreneurship through their entrepreneurship programmes/cells etc. Also big corporate houses back many startups nowadays. For instance, Ratan Tata recently invested in the Bangalore-based startup called Tracxn apart from many other investments in startups. But it is necessary to ensure that these opportunities also reach the lesser and the smaller cities and not just remain confined to the metros. An enabling

eco system should ideally comprise:

Enterprising individuals with risk-taking nature

Scalable business ideas

- Investors
- Market access

• Incubation centres/Mentorship programmes

Government policies/infrastructure

• Support from research organizations, financial institutes, educational institutes, big industries/corporate houses etc

Technological support

There is no dearth of scalable ideas and risk taking individuals in the smaller cities of India. It is only the other factors of the eco system that needs to be upgraded if we wish to see the similar rise of startups in these cities as that of the metros. However, a favourable trend is seen to be catching up lately with tier II and tier III cities becoming small startup hubs. Jaipur, Chandigarh, Jalandhar, Vadodara, Mysore, Udupi, Coimbatore, Goa, Nasik, Kochi, Indore, Bhubaneswar, Mohali, Kanpur, Thiruvananthapuram etc. are some of the best non metros to have come up with startup ideas and have received funding according to a recent survey. Another notable trend seen in these towns and cities is that many young individuals who were working in well-paying jobs in the metros are returning to their hometowns to start up on their own and to live their dreams. Hence, an eco system is slowly but steadily developing in the smaller towns and cities as well.

# Start Up Scenario in NER compared to rest of India:

While the whole of India is witnessing the startup revolution, a state like Assam and the entire North East region is yet to wake up to fully realize its potential in the startup segment. There is a strong need for an eco-system to boost the development of start ups in this region. With its

magnificent natural beauty, the region is blessed with resources that offer potential for businesses to thrive especially in sectors like agriculture, eco-tourism, food processing, e-commerce for native products and various other services. The government so far has been focusing on the North East region to put a thrust on the MSME sector and has been successful to an extent. According to

a report by International Finance Corporation, the North East region has 2, 00,000 micro, small and medium enterprises. However, in the context of start-ups the region is lagging behind in terms of an enabling eco system for young startups of the North East. Except for a few handful of young entrepreneurs who are trying to build a foothold in the startup segment, there is hardly any entrepreneurial activity in startups here. Reasons behind this are many:

Access to finance - Arranging finance is a key issue here. Number of projects financed by banks is very few compared to developed states. Financial institutions do not play an aggressive role which is evident from the fact that most of these institutions do not fund new projects/new ideas. Schemes like Angel Fund promoted by the Government are not reaching the right target group and hence no convincing results are observed.

Delays - Be it registration, bank loan application or any other government formalities, processes are extremely slow. Planning becomes very difficult under such circumstances. Easier registration process for setting up of business is a very important component for entrepreneurship development. Now with the single window Act in place, simplified registration process is expected to augment entrepreneurial activities in the state

Power Failure - This is a factor known to all which makes our produces costlier and lowers production rate, but there are hardly any steps being implemented to overcome this challenge.

Lack of Skilled Resources - This is a serious problem, especially for IT companies in the state. Since the brain drain is excessively high, lack of well qualified resources is very much felt. This proves to be a stumbling block for tech & IT start-ups to come up.

Lack of Big Industries - The recent surge in startups in India is dominated by the service sector. Most of the start-ups (especially the tech startups) formed in the past few years cater to the big organizations. Lack of such organization in the region makes it difficult for new service companies to sustain.

Though of late, some major trends have been visible in the startup scenario in NER, especially in Guwahati, following in the footsteps of the bigger cities. Young well educated boys from the region who were till now holding plush jobs at various organizations in the metros or outside of NER are now returning to their hometowns to start off their own ventures. This is a positive sign towards the growth of startups. But it is important to give them a platform to scale their business ideas. To have an enabling ecosystem in place, it is essential that the various stakeholders such as government departments, academic institutes of the state, financial institutes, research organisations, industry experts from the region etc. come together and build a support system for the aspiring/existing entrepreneurs ensuring low-cost Internet connectivity, favourable policies, ease of doing business, affordable education and skilling services, low-cost debt for priority sectors. Such collaborations can help in research and innovations since innovation is again a very critical and essential component of entrepreneurial initiatives. Such collaborations can lead to the setting up of incubation centres for entrepreneurs and mentorship programmes can be worked out. Mentoring is a very important factor for motivating/guiding the startups and Assam hardly has any mentoring programme.

Another notable trend of startups, as already mentioned at the beginning, is that most of the founders are from the premium educational institutes of the country like IITs, IIMs, IISc etc. This can be attributed to the entrepreneurial boost that is offered in the top colleges and universities like IITs, IIMs, IISc etc through incubation facilities, mentoring, networks with funders etc. Hence, there is a buzz of activity in the campus leading to the germination of ideas in the campuses. So many start-up founders of NER also come from these elite educational backgrounds. But to have a vibrant eco system and for promoting ideas, even the regional educational institutes can play a similar role of a mentor and incubator. This will give flight to the campus ideas that are cropping up in quite a number recently in the engineering colleges and management institutes of NER.

Majority of the information on startups from NER are based on random interaction with startup founders from the region and thus arrived at some of the observations. Major hurdle is that there is no properly documented data available on startups from NER in order to judge the exact scenario and this is a big gap. Thus, it is seen that NER has a long way to go to match up with the country's start up boom. This calls for proactive initiatives from all stakeholders and the government has a major role to play. There needs to be a synergy between all stakeholders.

#### Recommendations:

What is needed at the moment is to attract investors to NER. An enterprise trying to set up a business faces three obstacles - costs, procedural completeness and delays. These need to be addressed and eliminated to increase private investments into start-ups. Start-ups by rural enterprises across the agricultural, handicrafts and manufacturing sectors also need focus. Clarity on the definition of start-ups is also becoming essential to identify a business as a start-up and thus qualify for availing the start-up schemes. In this context, the GoI's Start Ups India initiative can be play a key role in building the future of startups in the NER. Funds announced by the Government should be accessible to all startups in the NER. Government can't guarantee that every entrepreneurial dream turns into a reality. But it can ensure that a good business idea is nurtured into a great business instead of getting killed because of absence of basics such as uninterrupted power, reliable mobile network, seed capital and clean and responsible administration. Hundreds of startups will be looking for such an assurance today.

# **STARTUPS** IN THE NORTH EAST REGION

orth East Region is a part of India that comprises eight states, namely Assam, Arunachal Pradesh, Meghalaya, Manipur, Mizoram, Tripura, Nagaland and Sikkim. These eight states are officially recognised under the North East Council (NEC) constituted in 1971 as the acting agency for the development of the eight States. The North Eastern Development Finance Corporation Ltd. (NEDFI) was incorporated on 9<sup>th</sup> August, 1995 and the Ministry of Development of North Eastern Region (DoNER) was set up in September 2001.

Despite the presence of institutions such as NEDFi and NEC, the region has been neglected for some reason or the other by the government so far, which has led to severe backlogs in the field of road, infrastructure, industrialization and modernization. But the present government's strong resolution of strengthening the North East Region is hopefully expected to produce fruitful

results.

It is worth mentioning that one of the major concerns is the growing number of unemployed youths of the region on the one hand and the richness in natural resources, tourism hotspots, agricultural products, florafauna and its strategic locations, which provides great connectivity with the rest of the South Asian Nations, on the other. This aspect really needs to be pondered.

Start-ups- A Strategy to cope with the North East Scenario:

According to business dictionary, Start Up refers to an early stage in the lifecycle of an enterprise where the entrepreneur moves from the idea stage to securing financing, laying down the basic structure of the business and initiating operations on trading.

Start-up India is an initiative of the Government of India intended to build a strong eco-system for nurturing



innovation and Start-ups in the country that will lead to sustainable economic growth and generate large scale employment opportunities as well.

Today, the utmost necessity of North East Region is to exploit and explore the areas and avenues of potential and try to reap the economic benefits out of it, and try to solve some of the employment issues.

Some of the Start-Ups of the North East Region which have been able to establish themselves as a prominent brand in their specified areas are as under:

1. Awe Rides- It is a car and bike rental company operational in Guwahati, Pune and Chandigarh. They provide both services to travellers, hence enabling them to explore the North Eastern Region as per their own convenience.

2. Sui Generis Inc.- This Start-up produces CC tea (which is naturally caffeine free) exclusively grown in Manipur, its aim is to start a green revolution in the state and highlight the huge natural resource potential of Manipur.

3. Nature's Gift- It is a Start-up in the state of Sikkim and it is currently one of the leading producers of ginger, turmeric, buckwheat and millets. Currently, it produces 200 tonnes of organic products every year.

4. Absolute Tea- It is a Start-up from the state of Assam which collects and sells fine Indian tea from legendary gardens, small tea growers and tea artisans. They provide the finest Indian tea to tea lovers across the world, hence paving their way for a much vibrant tea culture.

Government Support to Start-ups in North East India:

In the "Start-up India 2016" Conference, which was co-ordinated by the Associated Chambers of Commerce and Industry of India (ASSOCHAM), Union Minister of State for Development of North Eastern Region (DoNER) Dr Jitendra Singh stated that the North-East States of India have extreme possibility to enter the Start-up environment. The Central government is planning to create a venture fund for Start-ups.

Singh further stated that "the declaration of Sikkim as

the first organic state of India has opened up new avenues for start-up initiatives in organic farming in the North East". The minister placed his views by saying that though the world is currently witnessing a sluggish economic growth, Indian Start-ups will play the role in diversifying and strengthening economy as well as be able to create employment. The present government's new initiative can play a huge catalyst in the growth of a Start-up as the potential of North Eastern youths are yet to be explored.

Also Make in India is an opportunity created by the Narendra Modi led Union Government to make India a manufacturing hub and strengthen India's economic stand. This opportunity should be grasped immediately for the benefit of local entrepreneurs of the country, which would not only provide them with a living but would make them aware of global business standards.

However, to cope with the North East scenario, the following strategies can be adopted:

• Engaging local entrepreneurs in supplies.

• Taking assistance of local entrepreneurs in transportation.

• Helping young entrepreneurs in establishing ancillary industries.

• Establishing Common Facility Centres (CFCs) throughout the region, considering the locally available resources.

• Encouraging tourism giants to invest in North East to develop the available tourism spots into world class tourism centres.

• Improving the infrastructure.

To add further, the government should take initiatives to improve connectivity to and from the North East States to the country and the world as well. The most challenging part is that whatever efforts the government is putting in to boost start-ups in the region, it will ultimately be the responsibility and effort of the people of the North East to grab the available opportunities and try to establish enterprises with innovativeness, thus uplift the region economically, and to an extent, solve the unemployment problem.

To sum up, it may be mentioned that new ideas or creativity amongst the people, the availability of natural resources, place to provide training facilities, good connectivity along with the ease of doing business become a good package for taking up Start-up business. Ironically all the above mentioned factors can be found in North East Region, but the resources remain unexplored and unexploited for economic purposes. Here, it is pertinent that awareness regarding Start-ups be carried out by institutions such as the Indian Institute of Entrepreneurship, which was established in the year 1993 in Guwahati by the erstwhile Ministry of Industry (now the Ministry of Micro, Small and Medium Enterprises), Government of India.

# START SMALL, ACHIEVE BIG!

As start-ups keep mushrooming across the country, a few in the North East are also not far from their counterparts outside the Region as they take the less travelled path to battle the odds and achieve their dreams. The encouraging part is that most of them are starting young and giving the right shape to their business ideas. Here are some start-up ventures that are making a presence felt in the North East market:

# Bahniman Kakati, co-founder of TeaOrb, Guwahati

eet Bahniman Kakati, co-founder of TeaOrb Services, an e-commerce marketplace headquartered in Guwahati. TeaOrb now has registered suppliers (small tea manufacturers) not only from all tea-growing districts of Assam but also from other Northeastern States.

"Our story started in 2012, when I saw a major IT company s using digital marketing as an enabler to connect with customers worldwide looking for technical solutions and that triggered the possibility to deliver the freshest teas via internet. Towards this end, research was carried out in the tea consumption patterns in different counties of the world and India's share in that market. People were accustomed to drinking tea as it became available to them that were sanctioned by a century old system and it was time to make tea available as it should be, to everyone," Kakati, in his mid-thirties, said.

Bahniman and his father, Jayanta Kakati, immediately started working on a plan to offer an additional mode of sale to the centuries-old industry and popularize tea on the lines of fine wines and brand Assam as a tea destination along with promoting tourism in NE India, where tourists visit and stay in Heritage Bungalows in Tea Gardens. They wanted to offer visits and tours of fields and the tea factory to experience the toil and sweat that goes behind producing that exhilarating cuppa.

A concept paper was thus created and shared/discussed with a select few personalities from the industry and got support. The concept was shared with the Tea Board of India office in Guwahati, which gave support, and the company presented it to small tea growers in a workshop in March 2015. "Another presentation was made at a second workshop on market sourcing of organic tea, organised by the Tea Board in January last year. More interest was generated before the venture became a reality," he said. Using technology as an enabler, TeaOrb has created a Food & Beverage hybrid e-commerce marketplace for producers from North East, allowing them to collectively deliver their finest and freshest produce directly to consumers worldwide and fetch a better price as there are no intermediaries, affecting their payment capacity for better wage to tea workers and access to programmes and services to tackle climate change and offer tea tourism.

Apart from marketing and tourism, TeaOrb also have a consulting wing to provide guidance to producers in scientific agricultural practice in tea cultivation, modern manufacturing process in factory, marketing of the produce, matters related to Food Safety Standards Act 2006 and Tea Board of India's directives on Plant Protection Code (PPC).

"The company, TeaOrb, was incorporated on 29th May, 2015 and our portal platform, www.teaorb.com went live on December 21, 2016.

"This venture requires huge capital toward digital marketing, infrastructure and operations. It was initially thought that crowd funding would be the best option, but like introduction of any innovative idea, it



was difficult to bring about the required change in the mindset. The tech-savvy have understood the concept well. So with limited own resources we set about the task of o b t a i n i n g t h e n e c e s s a r y licenses/registration from the authorities.

"We have reached to a stage of actually marketing followed by fulfilment of orders but sadly our efforts to obtain finance from financial institutions have not met with success given the level of awareness on start-ups in this part of India. Indian Institute of Entrepreneurship has, however, provided us with valuable inputs to take the venture forward," Kakati said.

"We are now looking for angel investors to fund our venture, which we believe will be a success given our twin objectives to make tea available as it should be, to everyone and uphold the essence of sustainability to address real issues affecting people and the environment," Kakati said.

# Koinonia Juice Plant/Water Plant, Koinonia Water Plant

oinonia is a partnership firm registered under District Industries Centre, Aizawl and Ministry of MSME, Government of India.

"Koinonia Juice Plant was set up at Lengte, Mizoram in September 2011 with an office in Aizawl. "We now have a ready-to-drink brand, Koinonia Lemon Juice. Our office is located in South Kanan, Aizawl. We are certified by the certification body of Intertek (India) Private Limited having a license under the Food Safety and Standard Authority of India (FSSAI) and a consent to Operate from the Mizoram Pollution Control Board, Government of Mizoram," Ralte said.

"We started our business plan from the beginning of 2011 with our private consultant from the food processing consultancy and an architect for the factory buildings. The building project was estimated at Rs 44 Lakh and the machinery at Rs 40 Lakh. With our new upgrade plan in 2017, the machinery for juice processing is estimated at Rs 60 Lakh," he said.

In the year 2013, Food Processing Industry, Directorate of Industry, Government of Mizoram had granted Koinonia subsidy for their building and machinery under one of its schemes.

"For processing of our product, our main raw material is Assam Lemon. Within our owned farm at Lengte, which is as large as 3.8 Ha., we have planted 10,000 lemon trees, in which 8000 trees are up to satisfactory for picking during each season, which is further extracted into Lemon Juice," he said.

"Within a year, 25,000 litres of Assam Lemon juice was extracted from our own farm. As demand increased, we started procuring extracted lemon juice from different local growers within Mizoram. Before every purchase is made from the local grower, we have an analyzing meter for each lemon juice, before it is further procured, and after each and every quality testing has been passed to our standard of procurement," Ralte said.

Now, our annual estimated stock of lemon juice for processing of our products comes between 75000 to 100000 litres. In addition to this, water has been used for processing of the products, which is first collected from the water tank and further treated water at our Reserve Osmosis (R.O.) Plant. Again, in addition to this, an ingredient has been added," he said.

Activities such as personnel recruitment, sales, purchases, advertising and finance are carried out in their city office in South Kanan, Aizawl.

"All daily production records, dispatch records, stock records from the factory are recorded and maintained," he said.

In addition to our market expansion, we are planning to set up a new production unit within the North-East India, which will be in a medium or large scale unit. The project is aimed at capturing the markets of neighbouring Bangladesh and Myanmar.

# Milster Mushroom Farms

Age of the second secon

"By the time I left Delhi, my dreams became more lucid and thoughts concrete. I along with my friend, who shares similar philosophy of the corporate world like me, started the work of cultivating edible mushrooms. It was I believe equally hard for him to quit the job and join the start-up," Hrishikesh, in his early thirties, said.

"The very idea originated from the visits to the weekend vegetable market. Mushrooms at our dining table were a regular affair and there was only one dedicated seller of mushrooms in the entire market. This very thought made me ponder about this mysterious vegetable," he said.

Hrishikesh started doing research and homework to find out initially that people have a unique mindset for this commodity. "Those who are unaware of edible mushrooms perceive them to be poisonous. Contrary to this, the others who are in the know love to consume them," he said.

"I started meeting people associated with mushrooms in and around Guwahati. Needless to mention in this online world the World Wide Web helped a lot. Articles on mushroom and cultivation along with videos on YouTube etc. provided the much needed information. I and my friend also managed to attend a few seminars on Mushroom cultivation and the business associated with it," he said.

The mushroom market was much unorganised unlike any other vegetable market.

Assam is a protein deficit state and these wonder caps besides containing high levels of protein, have significant levels of fibre, iron, zinc, potassium, phosphorus, selenium, vitamins B1, B3, B5 and B12 along with vitamin C and Vitamin D. In fact mushrooms are the only source of Vitamin D from any plant source.

"I realised that such a super nutrient food needs to be promoted and cultivated as staple food in places like Assam along with the neighbouring states. It's a vegetable unlike any other vegetable which is organic in nature," he said.

Finally after much research and knowledge, it was time to put it in practical implication.

"It was a cold November morning in 2016 when we decided to make it official or rather practical. We had a very humble start at our home's garage. After gathering the required commodities (which was a different battle in itself) we made our first mushroom cylinder (Mushroom Bag) which would yield Oyster Mushrooms. The very first cylinder was a sight and the remaining 24 almost looks equally crooked as

we gained experience in making them," he said.

As the experiment phase was successful and the yields started shrinking with the passage of time, Hrishikesh decided to expand his farm with the limited financial resources he had. "The expansion started with (all the arrangements from million visits to thousand places) a slow pace and we finally were successful in putting up over 500 cylinders during the end of it. That was the most hectic yet memorable weeks of the entire mushroom journey till date," he said.

The market scenario for mushrooms is flourishing in Assam and especially in its neighbouring states. There is no definite structure for dealing in mushrooms and the product reaches the end consumer after rolling through a series of middlemen. This in turn leads to increased price of the product.

"By January, 2017, our product, "Milster Mushroom" – Go Organic Stay Fit, was launched in the market. We make small SKU of 250 Gms packets for retail and supply bulk orders as an when requirement arises. The same Oyster mushroom can be marketed as dried Oyster Mushroom but only if a food license is made. Mushroom Papad, Pickles, High Protein Powder for garnishing food items can be also be produced," he said.

However, funds were hard to come by. "We visited departments of Agriculture and Horticulture but small scale mushroom start-ups lacks funding. This is a major drawback which I feel demotivates us from doing our work. Even vermicomposting is possible with the expired mushroom cylinders and can be done in large scale owing to support from the Government schemes," Hrishikesh said.

"Packaging machines like Nitrogen packaging which increases the shelf life of the packed mushrooms if provided by the government with subsidized rates would be beneficial for transportation of this perishable vegetable," he said. Yoga involves focusing on holding postures for extended periods of time. This helps in improving your body balance and developing muscle tone.


#### 7. Relaxation and sleeping aid


